This course will explore the history, questions, values, and commitments that emerge within the theology and practice of Unitarian Universalist polity.

#### **Course Goals**

- 1) Students will develop a framework of critical questions with which to engage multiple situations of governance within congregations and the larger UU world as well as within diverse sites of ministry.
- 2) Students will deepen an understanding of the role of accountability in systems of governance, including accountability to an anti-racist, anti-oppression, multicultural Unitarian Universalism. This will include students examining their own embedded theology and how that may intersect with expressions of racism, classism, sexism, heterosexism, and settler colonialism in the UU faith.
- 3) Students will gain knowledge about the multiple roots in our U/U traditions that shape U/U polity, including significant moments of conflict, change, and social transformation.
- 4) Students will consider pathways for change in Unitarian Universalism through the lens of current and alternate models of polity.
- 5) Students will critically engage a number of the texts included on the "Required Reading List" of the Unitarian Universalist Ministerial Fellowshipping Committee.

#### **Course Assignments**

- 1) Regular class attendance and informed participation in class discussion

  To do well, please attend weekly and read the material for the day with reflective attention so as to participate in the discussion. Per HDS policy as of January 14, 2022, all classes will be livestreamed and recorded. As needed due to illness or emergency, please join online or watch the recording. (If you elect to watch the recording, a written reflection on the class will be required.) Everyone in the class is responsible for creating a classroom culture that justly creates space for all participants.

- 2) <u>Weekly Reflection and Questions</u>: Students will respond to the weekly reading with a short reflection concluding with a question the reading brings up. In addition, students will respond online to at least one question raised by others.

  Due Weekly by Midnight Thursday Graded Complete/Incomplete 20% (may miss 1; no papers 3/11; questions only 4/22)

- 3) <u>Lead up to two Class Discussions</u>: Drawing on the weekly reading, students will plan a 20-40 minute discussion. *Graded Complete/Incomplete 15%*
- 4) Midterm Paper: In a 3-5 page, double-spaced paper, students will respond to one of three proposed questions about "Widening the Circle of Concern."

- 5) <u>Future of UUism Conversations</u>: Conduct two 20-minute conversations with UU's of different social locations (one interviewee must be from a historically marginalized community), then write a 2-3 page reflection about what you heard and your own thoughts and questions about the future. Post to course site and respond to at least one question posted by another student.

Due Noon, Thursday, April 21 Letter Grade 15% Highly Recommend Interviews Complete by April 14.

6) <u>Final Paper:</u> In a 5-6 page, double-spaced paper, students will engage a current issue of polity in a congregational, community, professional, regional, national, or international context. The paper should describe the issue using cited resources, locate the issue within historical context, identify the dynamics of authority and accountability in the issue, and make a case for their own position on the issue. Students are strongly encouraged to discuss possible topics with the professor in advance.

#### **Class Format**

Each class meeting will primarily focus on discussion with some elements of lecture. Each class will pay close attention to the readings and students are encouraged to bring their questions, comments, and criticisms to class. While personal experience is valued as part of our sources of knowledge, students will be expected to foster a critical dialogue between experience, readings, and questions raised in class. Some class sessions will have a guest for part or all of the time. We will have a break midway through each class.
